Proposed Placement Policy 2017-18

All reputed industries and organizations as well our institute have been incurring considerable expenditure on the placement activity of Final Year students. Therefore, a student not joining the industry or organization after being finally selected reflects adversely on the Institute and, as a result, industry or organizations tend to discontinue their visit to college for placement. This jeopardizes career opportunities for future generations of our students. Students should, therefore, consider appearing at only such campus recruitment drive where they are willing to take up the job as soon as the selection is informed to the institute. Appearing at the campus recruitment drive as a matter of fun or practice should be avoided. Those who have firmly decided to other career field of his/her choice should refrain from appearing campus recruitment drive held at institute level or any other institute as a part of pooled campus recruitment drive. Placement is a facility provided by the institute & cannot be claimed as the right of any individual student.

Objectives:

- The Placement Cell endeavours to become a link between the job seekers [i.e. students] and job providers [i.e. companies] by building up their capacity and networking with Industries.
- Building a strong network among the corporate & institute for placements.
- Become the preferred choice of Employers with reference to Campus Recruitments for Management/ Executive positions in Corporate.
- Provide equal employment opportunities for all the students.
- To ensure sustainable employment for all our students through relevant education in today's scenario.

Eligibility Criteria for Placement Assistance:-

1. Eligibility criteria will be as per the norms of the company providing placement opportunity. A student shall be permitted to appear in campus recruitment drive subject to his/her meeting the criteria laid down by the visiting companies and the conditions put forward by the companies are acceptable to him.

2. Pre-requisite for placement:-

- a. Carrying out SIP is compulsory. (Failing to which there will be no placement assistance for the student doing so)
- b. CRT Audit Course Completion with minimum 90% attendance.
- c. The student shall appear/ be allowed for the campus recruitment drive of both the electives (i.e 1. Elective One & 2. Elective Two).
- d. Academic Attendance of 75% on the date of campus placement drive is mandatory for every student in final year to appear in the campus placement drive of any company.

Directive Principles, Rules and Regulations:-

1. Placement Cell will strive hard to provide placement opportunity to all its eligible not-eligible and interested students of Final Year.
2. In order to achieve its placement objectives, the Placement Cell shall organize various training programmes, Guest lectures, seminars, workshops, internship and other allied activities in addition to other similar academic/ non-academic activities for ensuring employability of its students.
3. The Placement cell shall also strive to invite various reputed Companies/ Organizations for recruitment/ placement of its students in field of their specializations.
4. It will be the endeavour of each student to co-operate with the Placement cell and to appear for opportunities offered for their Placement.
5. Any student having a job-offer in hand will not be allowed to appear for further placement opportunities unless and until all the eligible & interested students get one job-offer each in their hand. However, students will be given chances of upgrading their placement offers if the subsequent company / organization has been conferred with a “**Dream Status**” status by the Institute.
 - 5.1 The Institute may offer a “Dream Status” to any reputed company/organisation which has a very strong brand equity &/or is offering a very high salary package.
 - 5.2 “Dream Status” will be granted to a particular company by the Director, DMIMS and Director Placements MGI on the recommendations of TPO.
6. A student will have to join the company which gives “**1st offer letter**” in hand or Confirmation mail about selection irrespective of the process on going with other companies prior to the result declaration.

7. Once a student is enrolled with T & P Cell & if he/she fails to appear in any of the campus (Inhouse/ Pooled/any other) drive of any company without submitting a written application with justified and documents will not be eligible to appear for the next 3 consecutive campus placement drive. Habitual absenteeism will not be entertained (Even if it includes the DREAM COMPANY).
8. Once an offer is rejected by any student (Unless and Until if it is Genuine Reason) he/she will not be eligible for Placement and detained from any further campus placement drive.
9. Student cannot claim for placement if he/she fails to appear in 7 continuous chances provided by the Institute for Placement.
10. It will be mandatory for all the students registered with T&P to appear for all the campus Placement drive termed as “**Mandatory**” by the Training and Placement Cell irrespective of the type of company. The “**Mandatory**” status to any particular company will be provided by the Director Placements MGI. Any student skipping any “Mandatory” status campus recruitment drive without a justified reason and advance information will be detained from any further campus placement drive.
11. Once all eligible students secure one job-offer each, the students would be allowed to appear for all the further companies visiting for placement (inclusive of all closed, pooled and off campus).
12. If a selected student in any company through the campus placement drive fails to join the company without any justified reason he/she will not get clearance from the T&P Cell.
13. Any suggestions/ modifications/ deletion/ grievances in respect of the above policies shall be considered, if it found fit, on a case-to-case basis by the Manager – Corporate Relations in writing by the individual concerned student.

Rules and Regulations pertaining to Placement Process:

- No Preference related to Place of work will be entertained.
 - Students interested in Placement will have to enrol with T & P Office.
1. A notice of Placement Process once fixed will be communicated through E-Mail, SMS & What’s App for information of all students.
 - 1.1 It is important that all students must regularly check their E-Mail, SMS & What’s App for getting information on placement related activities.
 - 1.2 It will be students own responsibility to get updated on placement related processes and activities. (In case of any query student can visit to T & P office)
 - 1.3 Every student who enrolls with T & P Office and who has opted for “**Campus Placement**” in the registration form will be eligible (as per companies eligibility criteria) for all the Companies offering Placement.

2. Students those who do not enrol with the T & P Office, shall not be allowed to take part in the placement process under any circumstances later.
3. The students must think well before enrolling with T&P and then act accordingly i.e. enrolling with T & P is an act of expressing your desire and confirmation to join the organization on its terms and conditions, if selected. In order to maintain the institute's commitment to the organization, students will have to join the company from which they have received the offer letter. They will not be allowed to reject an offer at a later stage as per the policy already specified and decided by the authority. It should be noted, that students represent their personal commitment and the institute's commitment by such positive action.
4. Adherence to **Reporting Time** mentioned in the notice mailed/displayed must be taken into strictly consideration.
5. Dress code is **STRICTLY FORMALS**. Those who don't follow the dress code will not be considered for placements.
6. Individual details and Academics details must be updated on regular intervals by students to Training & Placement.
7. Students are not authorized to communicate with the companies in any individual capacity when company visits our college for placement. **Any corporate interaction by any student at any stage before and after selection must be carried out in consultation with Director, DMIMS, Director Placements MGI & TPO.**
8. If a student appears in written test and does not appear himself/ herself in front of the interview panel without seeking prior permission from Director Placements MGI /TPO, he or she will not be permitted for any future drives and will be detained for future placements.
9. If any student gets selected in any particular company and gets a joining date after one year of their passing year then in that case college authorities are not responsible for their joining pre-ponement. Also in any case if any company withdraws its offer letter/letter of intent at any stage before joining of any selected students the T&P Cell and Institute or any authority will not be responsible for it.
10. Students should refrain from using recommendations for getting placed in a company/corporate. Strict action will be taken against such students.
11. Students are expected to get enough information about the company, job profile and other details about the visiting company, search Company Website also before appearing for any recruitment drive. It is compulsory for students to visit the website of the visiting company before the campus placement drive.
12. Students should inform immediately about any change of Marks/Mobile No./Email ID to T&P Cell. The selected student will not change his Mobile Number & Email ID till he/she joins the company.
13. The T&P Cell will also try hard to arrange campuses of No Criteria Companies for not eligible students. The not eligible students should see that they get placed in the first opportunity of such companies which they get.

14. The institute [Through the Director Placements MGI] reserves its right to allow/ disallow any student from taking part in the placement process without assigning any reason thereto.
15. Decision of the Institute would be final and binding on all .Request/grievances/issues will be referred to the Director/Directors Placement/Director Training MGI forwarded through the TPO office.
16. Any suggestions/ modifications/ deletion/ grievances in respect of the above policies shall be considered, if found fit, on a case-to-case basis by the Director Placements and or Director Training in consultation with the Director forwarded through the TPO office in writing by the individual concerned student.
17. The Director Placements and or Director Training in consultation with the Principal reserves the right to take decisions on the cases which fall beyond the purview of above mentioned Policy, Rules and Regulation statements.

18. Rules: - In case of Multiple companies on same day

- a. In a scenario where a student is sitting for multiple companies which visits the campus on the same day, the student can appear for any number of companies. But, he/she will have to accept the offer from the company which comes out first with its list and gives a final offer to him/her first.
- b. The student will then be barred from appearing for any other company's placement processes and will be pulled out from their processes immediately, even if he/she is waiting to go in for an interview or GD.
- c. The other companies will also be informed that the student is placed and he/she should not be considered further.
